Cordia is one of 15 Society Master Saddle Fitters in the US. Olympians to weekend riding warriors she has fitted them all.

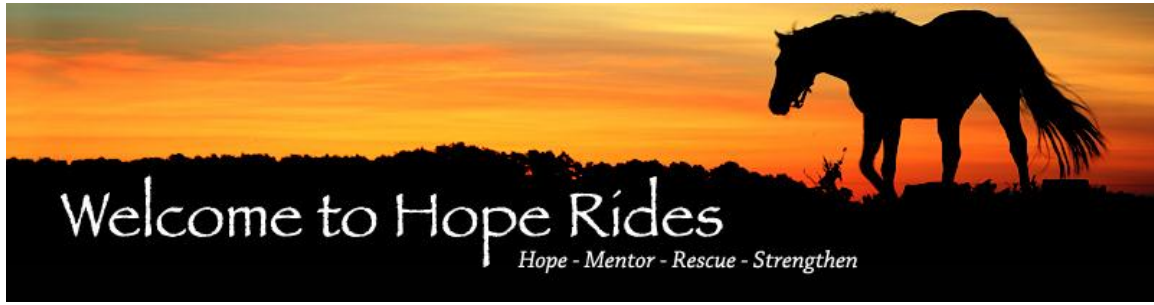

Waiver, Release and Indemnity Agreement
